The Hungarian Judicial Executors

- Chamber of Hungarian Judicial Executors
 - More than 600 members
 - ~ 900.000 cases/year
 - Supervised by the Ministry of Justice and Public Administration
- Profession regulated by the law
- Mapping of the debtors financial status
- Right to investigate in public databases
- Right to investigate with financial institutions
- Electronic signature since 2007 to fulfill specific legal requirements




The Concept

- Put to work the already existing electronic signatures
- Find standard procedures which can be automated
- No change in the paper based workflow
- Involve already existing technologies
- Involve as many participants as possible
- Assure legal conformity with e-signature
- Assure confidentiality with PKI based encryption



The Choice

Judicial Executors authority requests towards financial institutions and the reception of the answers





The Project

- Project began in the fall of 2008
- Associations of Banks involved
- Quick agreement on working principles
 - Legal environment
 - Use of e-signatures
 - Use of PKI based encryption
- Development in just 3 short months
- Go live in July 1, 2009






How it works



- This is being sent to all adressees
- Message: e-signed, timestamped, encrypted
- e-avis de reception
- Immediate message transfer (store-forward)
- Flexible: Mixed infrastructure on the end user side
- Automated: XML formats



The Numbers



~ 75 thousand messages monthly



Why it works

Electronization of a process that

- is in mass production
- continuous
- well automated
- The logic of the process is NOT changed
- Fixed internal data structure (XML)
- Flexible towards the end user (SMTP, HTTP(S))
- Small change but visible results
- Immediate savings for all









Key to success

Business logic works if

- No legal barrier exist
- Advantages manifest for all participants in the short run

Planning is essential


- Very well defined scope
- Business processes should change as little as possible
